3. Committee Members

4. Responsibilities

Chairman

- . Provide leadership and vision to the committee.
- . Oversee the implementation of green initiatives and monitor progress.
- . Approve the budget and resources required for green initiatives.

Convener

- . Coordinate and facilitate committee meetings.
- . Develop and maintain the Green Campus Initiative action plan.
- . Liaise with other departments and stakeholders to ensure the successful implementation of initiatives.

Members

- . Contribute to the development and implementation of green initiatives.
- . Provide expertise and support in their respective areas of responsibility.

5. Meeting Procedures:

Regular Meetings:

- The committee shall meet at regular intervals, as determined by the Chairman and Convener.
- Agendas and meeting schedules will be circulated in advance by the Convener.
- Minutes of the meetings will be recorded and distributed to all members.

Quorum

- A quorum shall be present for the meeting to proceed, with a minimum of three members, including the Chairman or Convener.

6. Initiatives and Projects:

Proposal Submission:

- Members can submit proposals for green initiatives to the Convener for review and consideration.
- Proposals should include details such as purpose, budget, resources required, and expected outcomes.

Implementation:

- Approved initiatives will be assigned to specific members for implementation.
- Progress reports will be provided at regular intervals to the Convener and Chairman.

7. Communication and Reporting:

- The committee will communicate updates and progress on initiatives to the college administration, faculty, and students.
- The Convener will be responsible for preparing reports on the committee's activities to be submitted to the college management.

8. Review and Amendments

- Proposed amendments will be discussed in committee meetings and implemented upon approval by the Chairman.
