## **B. Statement of purpose:**

To foster a safe and inclusive campus environment by enforcing appropriate measures to prevent and address any form of harassment or intimidation, ensuring the well-being and dignity of every student.

## **C. Functions of the committee:**

- i. Implement and enforce a zero-tolerance policy towards ragging, ensuring a safe and secure environment for all students within the college premises.
- ii. Conduct regular awareness programs to educate students about the harmful consequences of ragging and promote a culture of respect and empathy.
- iii. Promptly investigate and address any reported incidents of ragging, taking appropriate disciplinary actions against the perpetrators in accordance with college policies and legal guidelines
- iv. Provide confidential channels for students to report ragging incidents, ensuring the protection of whistleblowers and maintaining anonymity when necessary.
- v. Regularly evaluate and enhance the institution's anti-ragging policies through systematic monitoring and reviews, ensuring their ongoing effectiveness and alignment with evolving needs and standards
- vi. Collaborate with local authorities, law enforcement agencies, and NGOs to strengthen anti-ragging efforts and promote a wider societal awareness of the issue.

#### **D. Powers of the committee**

- i. The committee has the authority to recommend disciplinary actions against individuals found guilty of engaging in ragging activities, in accordance with established institutional policies.
- ii. The committee is empowered to implement and enforce the institution's anti-ragging policies, ensuring compliance and adherence throughout the campus community.
- iii. The committee is authorized to communicate anti-ragging policies and measures to the entire college community, emphasizing the importance of compliance and cooperation.
- iv. The committee has the power to receive and address complaints from students regarding incidents of ragging, ensuring a confidential and accessible mechanism for reporting and redressal.
- v. The committee can propose amendments to anti-ragging policies, subject to approval by relevant authorities, to address emerging challenges and enhance the effectiveness of preventive measures.
- vi. The committee has the power to collaborate with external organizations, law enforcement agencies, and community stakeholders to strengthen anti-ragging initiatives and address the issue comprehensively.

#### **E. Procedure to register complaints:**

- i. Online mode (Email to authorities; email ids provided on college website)
- ii. Anonymous reporting (by any means)
- iii. Directly to the committee
- iv. Helpline number (displayed on campus)

**F. Procedure to set up an appointment:**

- i. After receiving and reviewing the complaints appropriate appointments with the concerned parties will be made to make sure anonymity and confidentiality are maintained

**G. Frequency of meetings:**

- i. At the beginning of each academic year.
- ii. Every 4 months
- iii. Emergency meeting as and when required.

**H. Tenure of the committee:**

The core/faculty members of the committee shall be reviewed and modified every two years. The student representatives shall be modified every year.
